"STANDARDS OF SCHOOL NURSING PRACTICE.

Standard I. THEORY

The school nurse applies appropriate theory as basis for decision making

in nursing practice.

Standard II. PROGRAM MANAGEMENT

The school nurse establishes and maintains a comprehensive school

health program.

Standard III. NURSING PROCESS

The nursing process included individual health plans which are

developed by the school nurse.

Standard IV. <u>INTERDISCIPLINARY COLLABORATION</u>

The school nurse collaborates with other professionals in assessing, planning, implementing and evaluating programs and other school

health activities.

SCHOOL NURSE- SUMMER PROGRAM

The Cabell County Health Services/Nurses shall be licensed to practice in the State of West Virginia as registered professional nurses and shall be certified as a school nurse in the State of West Virginia. He/she is directly responsible to the Summer School Administrator. Preference for filling this position shall be given to those currently working as school nurses in Cabell County.

The School Nurse will:

- 1. Review the immunization and health records of all students enrolled. Assist in maintaining up-to-date emergency cards on all students.
- 2. Keep accurate health records on all children and assist other school personnel in interpretation of data on should it be Emergency/Health Card.
- 3. Provide medication training to teachers and/or administrators.
- 4. Provide instruction to teachers on the administration of medical procedures needed by individual students per their health records.
- 5. Serve as a resource person to school personnel in matters of health instructions.
- 6. Communicate with parents of enrolled students as needed regarding issues related to the health and medical needs for their child.
- 7. Exclude children suspected of harboring communicable disease until diagnosed and treated by a physician.
- 8. Instruct students and school personnel in effective methods of controlling the spread of communicable disease.
- 9. Administer first aid to injured or ill students.
- 10. Assist in setting up procedures for chronically ill students who may become emergencies while at school. (Individual Health Plan)
- 11. Design, implement and monitor procedures for safe administration and storage of all medications. (Individual Health Plan)
- 12. Inspect and gather or order needed first aid supplies and arrange for restocking depleted items.
- 13. Communicates effectively with teacher regarding health related matters or needs of individual students.
- 14. Cooperates with other state and local agencies, i.e., state and local physicians, contacting them as needed for clarification on student health and medical needs.
- 15. Screen vision or hearing of students should a concern be noted by the nurse and/or teacher of the need for such a screening.
- 16. Make referrals when necessary on vision and hearing inadequacies and assist indigent parents in obtaining corrections through the use of various social service agencies.
- 17. Follow up on all referrals and assist teacher in making adjustments in programs and seating arrangements when correction is not possible.
- 18. Any and all other tasks assigned by the Director of Special Education related to the health and well-being of enrolled students.
